

## Clinician Job Description: Full or Part-time

Licensed Psychologist (or license eligible/post-doc)/ Licensed Therapist (LPCC or LCSW)

- Independently licensed (Psychologists, LCSW, or LPCC) in the State of Kentucky (must be fully licensed, or license eligible/post-doc)
- Solid clinical background with strong ability to connect with others in a therapeutic manner, and commitment to high quality and ethical practice

## Job Duties and Responsibilities:

- 1. Provide clinical counseling services (on site and/or via telehealth), engaging in strong therapeutic relationships, while practicing with a high level of skill and ethical standards.
- 2. Regular, reliable attendance and timely arrival to work is required, as well as the demonstration of professionalism.
- 3. Maintain current license, and continuing education; abide by all laws, rules, regulations, and codes of ethics in all services provided on behalf of Viewpoint Psychological Services.

- 4. Respond to client requests for service or calls within 24 hours whether such requests are made in person, by phone, voicemail, etc.
- 5. Communicate with a client's treatment team (i.e., PCP, psychiatrist, school, etc.) as necessary.
- 6. Maintain written records in a timely fashion, including, but not limited to: intake notes, progress notes, treatment plans, termination notes, contract notes, and other forms or documents or third parties; Keep client files current and accurate.
